

Dear Guest,

We inform you that this electronic device is used to carry out the reception operations, apply the signature in digital format on the Welcome Card General Card and fulfil the obligations established by current legislation on Privacy. The device complies with the R.D. 773 31 T.U. of Public Security and subsequent amendments, Legislative Decree 196/03 T.U. of Privacy and subsequent amendments and with EU Regulation 2016/679 and subsequent amendments. We inform you that the processing of your personal data, also carried out with the aid of IT means, is based on principles of correctness, lawfulness, transparency, relevance and non-excess with respect to the purposes for which they are collected and in full compliance with your rights.

Why we ask you for data

- a) your data will be processed to manage the service requested by you and perform the related obligations. The provision of these data may in any case be legitimately carried out by Mi.No.Ter S.p.A. without your consent, for the execution of contractual services requested or provided for by you in your favor, for the fulfilment of obligations imposed by law on Mi.No.Ter S.p.A. for the performance of administrative and accounting activities and for the pursuit of legitimate interests of Mi.No.Ter S.p.A. In the absence of such data we would not be able to provide you with the requested service correctly.
- b) In case of your consent, some of your data (such as, for example, name, surname, residence, telephone numbers and e-mail), may be used for information and commercial promotion purposes, in particular, sending newsletters and advertising material through the use of remote communication techniques including automated contact methods (such as SMS, MMS, fax, e-mail, messages on web applications) and traditional (such as paper mail).

We may process any of your personal data falling within special categories of data (e.g. relating to your state of health) only after obtaining your explicit consent. We remind you that you can always revoke any consent given; The revocation does not affect the lawfulness of the processing carried out up to that moment. Furthermore, your presence in the Hotel may be communicated to third parties who request it only with your consent, aimed at receiving messages and phone calls addressed to you.

How we process your data

To pursue the aforementioned purposes, your data will not be disseminated and will be processed with appropriate methods and procedures, including IT and telematics, and may only be known by the personnel appointed by our structure and by external subjects of our trust to whom we entrust some tasks of a technical and organizational nature, who operate as data processors on our behalf. Your personal data will be kept in full compliance with the security measures provided for by current legislation on the protection of personal data. For the purposes referred to in point A they will be kept for the time required by the legislation on the conservation of documents for administrative, accounting, tax and contractual purposes. Your data may also be processed, for the purposes referred to in point B, as well as by Mi.No.Ter. S.p.A., also by companies specialized in information and commercial promotion services and customer care that will operate as data processors. For the purposes related to commercial communications (point B) your data will be kept for a longer period or until your possible withdrawal of consent.

What are your rights.

The privacy legislation (articles 15-22 of EU Regulation 2016/679) guarantees you the right to access at any time the data concerning you, as well as to obtain their correction and / or integration, if inaccurate or incomplete; their cancellation or portability of the data provided by you. The privacy policy also gives you the right to request the limitation of the processing of data, if the conditions are met, or the opposition to their processing for reasons related to your particular situation. You also have the right to revoke your consent to the processing of data at any time and without charge, by contacting Mi.No.Ter S.p.A. at the contact details indicated below.
